ORDER

The 16th April 2005

(In the matter of Election into Primary Co-operative Societies under  
Dhenkanal Division, Dhenkanal)

No. 1197–EV-1/2002—Where this has been brought to my notice that election of the following Primary Co-operative Societies in the Angul Circle in the Revenue District of Angul as given at the Schedule hereunder are required to be conducted, so as to restore democratic management through the process of election as envisaged under the existing provisions of law i. e., O.C.S. Act, 1962 (Act 2 of 1963), and O. C. S. Rules, 1965 and O. C. S. (Election to the Committee) Rules, 1992.

Now, therefore, in exercise of powers conferred under Section 28 (A)(2) of O.C.S. Act, 1962, Rules 3 and 4 of O. C. S. (Election to the Committee Rules, 1992) as amended in 1997, read with Order No. 25502, dated the 25th October 1992 of Registrar of Co-operative Societies, Orissa, I, Shri B. C. Sethi, Deputy Registrar of Co-operative Societies, Dhenkanal Division, Dhenkanal do hereby appoint the following officers as Election Officers of the following Co-operative Societies as indicated against their names and do hereby direct the management and Secretaries of the concerned Co-operative Society to initiate and complete the election of the Committee of management by fixing date/dates/time and to conduct and complete the process of the election of President and Vice-President from amongst the elected Committee members by fixing another date/dates subsequently after completion of the election of the Committee members so as to complete the entire process by the 2nd July 2005.

This order supersedes all other orders issued earlier in this regard.
