ORDER

The 19th August 2005

No. 2770-SEC.—Whereas it is reported by the Executive Officer, Puri Municipality that casual vacancy in the office of Chairperson of Puri Municipality has occurred due to resignation of Shri Benudhar Sethi, which was accepted by the Municipal Council in their meeting dated the 28th July 2005.

And whereas, it is necessary to fill up the said causal vacancy ;
