### NOTIFICATION

The 27th August 2005

**S.R.O. No. 337/2005**—In exercise of the powers conferred by sub-section (1) of section 67 of the Motor Vehicles Act 1988 (59 of 1988) and having regard to the provisions of clauses (a) to (d) of the said sub-section and in supersession of the directions issued in the notification of the Government of Orissa in the Commerce & Transport (Transport) Department No.708/LC-IV-Gen-18/2003-T., dated the 16th January 2004 published in the extraordinary issue No.104 of the *Orissa Gazette*, dated the 17th January 2004, the State Government do hereby issue the following directions to the State Transport Authority, Orissa, namely:—

### DIRECTIONS

The freight for goods carriages plying within and outside the State of Orissa shall be fixed as specified in the Schedule given below with effect from the date of publication of this notification in the *Orissa Gazette*.

### SCHEDULE

| Sl. No.<br>(1) | Categories of goods carriages<br>(2)   | Rate of freight per kilometre<br>(3) |
|----------------|--|--------------------------------------|
| 1              | Standard type goods carriages having carrying capacity of 8.5 to 10 Metric Tonnes plying inside the State. | Rs.17.99                             |
| 2              | Standard type goods carriage having carrying capacity of 8.5 to 10 Metric Tonnes plying outside the State. | Rs.18.44                             |
| 3              | Four wheelers light vehicles carrying capacity of 2 to 3 Metric Tonnes.                                    | Rs.10.38                             |
| 4              | Six wheelers light Commercial vehicles   | Rs.11.81                             |

**NOTE—** (i) The above rate is the minimum rate excluding loading and unloading charges.

(ii) Extra charge of 10% on freight may be taken for carriage of hazardous goods like all types of acids, liquid, gas and explosives excluding petrol, diesel and lubricants.

(iii) For carrying personal effects on account of transfer of personnel, shifting of place of residence/accommodation and for transportation of agricultural products (not in course of trade or not in connection with trade)/construction materials like bricks, sand, chips, etc, the above rate of freight shall not be applicable in which case contractual rates are to be adopted.

(iv) For transportation of goods in the goods carriages having more than two axles the above rate of freight shall not be applicable in which case contractual rates are to be adopted.
