In exercise of the powers conferred by sub-section (1) of Section 31 of the Orissa Co-operative Societies Act, 1962 (Orissa Act 2 of 1963) as modified in the Orders of the Government of Orissa in Co-operation Department issued under Section 123 of the Act as specified in Column 3 of the Schedule given below and in supersession of the previous Notifications issued in pursuance of the said Orders, the State Government do hereby withdraw the nomination of the President/ Management-in-Charge/ Vice-President and Members of the Managing Committee of the Co-operative Societies listed under Column 2 of the Schedule by the Notification in Column 1 of the Schedule to enable the Registrar of Co-operative Societies-*cum*-Chief Electoral Officer of Co-operative Societies, Orissa to hold elections for constitution of their Managing Committees.
