RESOLUTION

The 31st July 2006

SUBJECT—Shifting of Coir, Khadi and Salt Programmes to the Directorate of Industries, Orissa

After careful consideration, Government have been pleased to transfer the Coir, Khadi and Salt Programmes from administrative control of the Directorate of Handicrafts and Cottage Industries (D.H. & C.I.), Orissa to the Directorate of Industries, Orissa for better co-ordination with the Ministry of SSI and ARI which is the Administrative Ministry for the above mentioned schemes. The D.H. & C.I., Orissa will continue to implement Handicraft Sector Programmes in co-ordination with the Ministry of Textile, Government of India, which includes craft programmes under coir or natural fibre.

After transfer of Coir, Salt and Khadi Programmes to the Director of Industries, Orissa the administrative arrangements for better implementation of these programmes shall be made as indicated below :—

- (i) The post of Assistant Director (Coir), Coir Supervisor, Senior Assistant/Senior Clerk/ Coir Instructor/Peon/Messenger/Watchman attached to the Coir Section of D.H. & C.I. will continue at D.H. & C.I. to look after the craft development programme for coir and other natural fibre as well as ongoing schemes in Coir Sector including submission of U.C., etc.
- (ii) The posts under Salt Scheme like Assistant Director (Salt), Development Officer (Salt) and other posts will continue at D.H. & C.I. to look after Handicraft Programmes as would be allotted by Director, H. & C.I. These staff will also look after implementation of ongoing salt programmes including submission of U. C., etc.
- (iii) The staff for the Coir and Salt Programmes working in the field will work under the Director of Industries, Orissa and the budget will be accordingly adjusted between

two Directorates during supplementary budget. Till then the staff of both the sectors will continue to get their salary from the D.H. & C.I., Orissa.

- (iv) The ongoing schemes in Salt and Coir Sector under Additional Central Assistance (A.C.A.) 2005-2006 will continue to be implemented by D.H. & C.I., Orissa and U. C. for the amount is to be submitted by D.H. & C.I.

All matters relating to Coir Industries, SFURTI and all other schemes including matters relating to Orissa State Coir Co-operative Federation will be looked after by Directorate of Industries.
