ORDER

The 27th January 2006

No. 307—Ele. (MI)-10/2006-SEC.—Whereas it is reported by the Executive Officer, Kamakhyanagar N. A. C. that casual vacancy in the office of Chairperson of Kamakhyanagar N. A. C. has occurred due to no-confidence motion passed against the Chairperson on the 10th January 2006 ;

Whereas it is necessary to conduct by-election to fill up the said casual vacancy.

Now, therefore, in exercise of powers conferred under Section 49 of the Orissa Municipal Act, 1950 and Rule 68 of the Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, the State Election Commission appoints following dates for holding election to fill up the aforesaid casual vacancy.
