**HOME DEPARTMENT**  
**RESOLUTION**

The 31st August 2006

SUBJECT—Grant of pension to the widows of Second World War Veterans belonging to the State of Orissa.

The Government had framed, in the Home Department Resolution No. 19982, dated the 31st March 2001, a scheme for payment, with effect from the 1st April 2001, of monthly pension of Rs. 500 to the non-pensioner Second World War Veterans, who are *bona fide* residents of Orissa. Since then such pensions have been sanctioned to large number of Veterans. After the death of many such pensioners, their widows have represented for the payment of pension to them. While widows, of the non-pensioner Second World War Veterans, are eligible to get the monthly pension, where it was not sanctioned earlier to their deceased husbands, there is no expressed provision in the aforesaid Resolution for payment of pension to those widows, whose husbands were sanctioned this pension.

2. After careful consideration, Government have been pleased to extend, the benefits of this monthly pension, also to those widows, whose husbands have expired after this pension was sanctioned to them by the Home Department, provided the widows are over 60 years of age. Therefore, the Government have been pleased to order that in the Home Department Resolution No. 19982/Poll, dated the 31st March 2001:

- (i) The existing paragraph 7 (c) shall be renumbered as 7 (d),
- (ii) A new paragraph, numbered as 7 (c), shall be added as below:

“Para-7 (c) : After the death of this monthly pension holder, his widow or husband, as the case may be, will be eligible to get it at the same rate till her death or re-marriage, whichever is earlier, subject to other terms and conditions prescribed in this Resolution.”

(iii) In Form No. II, after serial number 4 (e), a new serial number 4 (f) shall be added as below :

“4 (f) : If the husband/wife of the Applicant was receiver of this monthly pension and has died, the date of death with certificate and letter number & date of the pension sanction order.”

3. This has been concurred in by the Finance Department vide their UOR No. 691/MF., dated the 8th June 2006.
