NOTIFICATION

No. 56/2006(i)-JUD.-III—In pursuance of sub-paragraph (2) of Paragraph 17 of the Election Symbols (Reservation & Allotment) Order, 1968, the Election Commission of India hereby makes the following amendments to its Notification No. 56/2006/JUD.-III, dated the 6th March 2006, namely :—

I. *In Table II* (State parties), appended to the said Notification

 - (v) against Sl. No. 627, the existing entries under column 2 shall be substituted by the entries "Lok Bharati".
- III. *In Table IV* (list of Free Symbols), the entries "12. Bell" and "48. Lock & Key" shall be deleted.
