No. 4380-SEC.—Whereas it is reported by the Executive Officer, Kabisuryanagar N.A.C. that casual vacancy in the office of Chairperson of Kabisuryanagar N.A.C. has occurred due to resignation tendered by the Chairperson on the 6th November 2006 ;

Whereas it is necessary to conduct by-election to fill up the said casual vacancy.
