ORDER

No. 4836—Ele. (ML)-46/2006-SEC.—Whereas it is reported by the Executive Officer, Digapahandi N.A.C. that casual vacancy in the office of Chairperson of Digapahandi N.A.C. has occurred due to resignation tendered by the Chairperson on the 5th December 2006.
