NOTIFICATION

The 26th December 2006

S.R.O. No. 674/2006—Whereas, the Government of Orissa in the Panchayati Raj Department have, by notification issued under sub-rule (1) of Rule 4 of Orissa Panchayat Samiti Election Rules, 1991 published in the Official Gazette on the 22nd December 2006 called upon all the Samiti Constituencies in the State to elect their Members for the purpose of constituting the Panchayat Samitis. However, in obedience to orders of Hon'ble High Court in Misc. case No.7903 of 2006 arising out of OJC No. 8975 of 2006, no poll schedule for the members of Panchayat Samiti, Basudevpur shall be published without permission of the Hon'ble High Court, accordingly Election Officer shall not issued notice calling for nomination for Panchayat Samiti Member of Basudevpur Panchayat Samiti in the district of Bhadrak without leave of the Hon'ble High Court ;

Now, therefore, in exercise of powers conferred under Article 243-K of Constitution of India and Rule 4 (2) read with Rule 17 of the aforesaid Rules, the State Election Commission hereby appoints the following dates and time with respect to the said elections :—
