ORDER

The 11th May 2006

No. 1633—Ele. (ML)-10/2006-SEC.—Whereas Municipal Commissioner, Bhubaneswar Municipal Corporation has reported about occurrence of casual vacancy in the office of Corporator of Ward No. 9, Bhubaneswar Municipal Corporation due to disqualification of Corporator declared by the Hon'ble High Court in W.P. (C) No. 6537/2005;

Whereas, the State Election Commission has decided to update the electoral roll of Bhubaneswar Municipal Corporation on the basis of Assembly Electoral Roll published by Election Commission of India/C.E.O. during March, 2006 and which is currently in force;

And whereas, it is necessary to prepare updated Electoral Roll for Bhubaneswar Municipal Corporation for the by-election ;

Now, therefore, the Commission, in exercise of the powers vested in it under Article 243ZA of the Constitution of India directs that Wardwise preliminary Electoral Roll of Bhubaneswar Municipal Corporation shall be prepared as per manner prescribed in Schedule-I by the Commission according to the programme laid down in Schedule-II of this Order.

SCHEDULE-I  
PROCEDURE FOR PREPARATION OF THE ELECTORAL  
ROLL FOR BHUBANESWAR MUNICIPAL CORPORATION

1. The Election Officer appointed by the Commission will be in charge of preparation and finalisation of the electoral rolls of the Bhubaneswar Municipal Corporation.
2. The Electoral Roll of the Assembly Constituency prepared by the Election Commission of India published during March, 2006 (currently in force) shall be the basis for preparation of the preliminary Wardwise electoral rolls of the Bhubaneswar Municipal Corporation.
3. Preliminary electoral roll for each Ward shall be prepared in accordance with Rules 5 and 6 be published in accordance with Rule 8. It should be ensured that the copies of the preliminary electoral roll or the portion thereof, as the case may be, relating to each Ward shall be kept open for inspection by the public for a period indicated in the programme drawn up by the Commission vide Schedule-II. An Assistant/Clerk may be entrusted to help the public in the inspection of the preliminary electoral roll during the period.
4. It has been provided in Rule 8(4) that the fact of publication of preliminary electoral roll shall be notified in one or more **Oriya Newspapers** circulating in the district. A model format in Oriya is given at Appendix 'A' of this schedule which may be published with necessary modification in **one newspaper between the 18th May 2006 to the 24th May 2006**.
5. Any person whose name is already enrolled in the Assembly Electoral Roll, 2006 but not finds place in the Wardwise voter list now prepared as per Para. 3 above can file claims/objections for enrollment/correction in the entry in Form Nos. VII & VIII respectively. **It is made clear that fresh claims for enrollment as voter shall not be entertained.**
6. After hearing and disposal of claims and objections and finalisation of the electoral roll by the Election Officer U/R 12, the final electoral roll shall be published for three consecutive days at the prescribed places U/R 16. The Commission has prescribed a model form at Appendix 'B' of this schedule to be used for final publication of the electoral roll.
7. The final electoral roll shall be authenticated under signature of the Election Officer concerned with date and official stamp as follows :

“Certified that the electoral roll of Ward No.....of Bhubaneswar Municipal Corporation has been duly prepared and the final roll duly published as per the provisions of Orissa Municipal Corporation (Division of City into Wards, Reservation of Seats and Conduct of Election ) Rules, 2003 on .....

8. The final electoral roll so published shall then be split up Polling Station/boothwise (each booth allotted to about 1,000 voters) in accordance with Commission's direction in the matter.
9. After splitting of the final electoral roll boothwise, **only the Electoral Roll of the Ward where by-election will be held shall be printed** as per requirement (Ideally @ 3 copies per booth+Copies to Political Parties +Commission's Copy + Office Copies). Photostat copies of the electoral roll of the other Wards of Corporation shall be duly authenticated and forwarded to the Commission. On request each National Party/State Party shall also be supplied a copy of the same free of cost.
