ORDER

No. 1666—Ele. -GP-1/2006-SEC. —Whereas the Collectors, Sub-Collectors concerned have reported that there was failure of election to the office of Ward Members and Sarpanches as given in the Annexure as no nomination was filed and the programme for revision for electoral roll have been communicated vide Commission's Order No. 1254, dated the 4th April 2006.
