S. R. O. No. 240/2006—In exercise of the powers conferred under Section 21 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the surveyed land situated in Sadar Tahasil under Sadar and Kanjipani P. S. of Keonjhar district, the limits of which have been demarcated by the cairns and lines cleared to a width of 20 feet or by natural boundary as specified below shall be Reserved Forest with effect from the date of issue of this notification and shall be known as the “Mundula” Reserve Forest in Keonjhar in the district of Keonjhar :

Description

The Block is demarcated by 170 Pillars. No portion of this Block is included in any surrounding village area.

Admitted Rights—

(a) People are allowed to collect the edible roots and fruits inside the Reserve Forest for their domestic consumption only.

(b) They are allowed to use the footpaths inside the Reserve Forests

(c) Grazing of domestic animals up to foot hill is allowed from October to June without damaging to the existing forest growth. No grazing is allowed in the plantation to be taken up and in the degraded forest.

(d) These rights are not to be bartered or transferred.
