NOTIFICATION

S. R. O. No. 63/2007—Whereas election to the office of Panchayat Samiti Member of Adanigarh Samiti Constituency under Harbhanga Panchayat Samiti has been countermanded as per Rule 46-G (1) (b) of the Orissa Panchayat Samiti Election Rules, 1991 by the Election Officer and intimated to the Commission vide Memo No. 120, dated the 19th January 2007 by Collector and Election Officer, Boudh and in compliance to the Orders of the Hon'ble High Court, Orissa in W. P. (C) No. 1049 of 2007, the election to the Samiti Constituency, Adanigarh shall be held afresh.
