ORDER

No. 5111—Ele.(GP) -110/2007-SEC. — Whereas, the Collectors, Mayurbhanj and Puri have reported that due to death/resignation of elected Zilla Parishad Member of Kusumi -11, Pipili - 24 and Puri Sadar-26 Zilla Parishad Constituency respectively casual vacancies have occurred in the said offices.
