No. 14136—IX-SME(Sch.)-3/2005(Pt.)-SME.—The eligibility of following 8 (eight) Private High Schools appearing at SI. Nos. 80, 181, 183, 316, 334, 573, 747 and 1119 in the list of 1294 High Schools eligible to receive Grant-in-aid as aided educational institution w.e.f. the 1st January 2004 notifed vide School & Mass Education Department Notification No. 262, dated the 20th February 2004 was under review of the Government. The Government in School & Mass Education Department after careful consideration have decided that the date of eligibility to receive Grant-in-aid as aided institutions of the following 8 (eight) Private High Schools shall be from the date of eligibility indicated against each i.e. the date the institutions have appointed qualified teachers in their respective institution instead of the 1st January 2004:
