SUBJECT: Restructuring of Orissa Administrative Service cadre.

Proposal for restructuring of Orissa Administrative Service cadre was engaging the attention of Government for sometime. Keeping in view the requirement of O.A.S. officers in higher hierarchy in different Departments and offices, Government after careful consideration have been pleased to restructure the cadre by upgrading some posts to next higher rank as detailed at Annexure I without exceeding total authorised cadre strength of 2030 (Two thousand thirty). The revised Cadre Schedule of O. A. S. officers in the rank of Joint Secretary and above is appended at Annexures II and III.

The revised cadre would come into force with immediate effect. This issues with the concurrence of Finance Department in their U.O.R. No. 1401-PSF., dated the 25th April 2007.
