NOTIFICATION

The 7th February 2007

S. R. O. No. 83/2007—Whereas the State Government in exercise of powers conferred by Section 3, read with Section 149 of Orissa Grama Panchayat Act, 1964 (Orissa Act 1 of 1965) reconstituted the Gramas of Ganjam district in the notification of Government of Orissa in the Panchayati Raj Department No. 19158—L.S.II.-22/2001-G.P., dated the 20th October 2001 published in the Extraordinary Issue No. 1999, dated the 29th October 2001;

And whereas M. Narasinhulu Reddy and others filed a writ application before the Hon'ble High Court bearing OJC No. 4089 of 2002 challenging the inclusion of village Korapalli in Chamakhandi Grama in the said notification;

And whereas the Hon'ble High Court in their judgement and order, dated the 8th December 2006 passed in the aforesaid writ application quashed the said notification, dated the 20th October 2001 so far as it relates to inclusion of village Korapalli in Chamakhandi Grama;

And whereas the State of Orissa filed a Review Petition bearing No. 8/2007 (arising out of OJC No. 4089/2002 disposed of on the 8th December 2006) and the Hon'ble Court has also dismissed the review petition by their judgment and order, dated the 2nd February 2007;

And whereas the State Government after considering the facts and circumstances of the case, as directed by the Hon'ble High Court, decided that the village Korapalli shall be excluded from Chamakhandi Grama and shall be included in Laxmipur Grama.

Now, therefore, in exercise of the powers conferred by Section 3, read with Section 149 of Orissa Grama Panchayat Act, 1964 (Orissa Act I of 1965) the State Government do hereby make the following amendments to the said notification, namely :—

AMENDMENT

In the Schedule to the said notification for the Grama(s) "16—Chamakhandi" and "17—Laxmipur", appearing in column (3) against the Block "Chhatrapur" under the

Subdivision “Chhatrapur”, with their villages comprising local area and the population thereof respectively occurring the columns (4) and (5), the following gramas, villages comprising local area and the population shall be substituted under appropriate columns, namely:—
