No.7482—WCD— In pursuance of sub-sections (1) and (2) of Section 4 of the Juvenile Justice (Care & Protection of Children) Act, 2000, r/w Rule 3 of the Juvenile Justice (Care & Protection of Children) Orissa Rules, 2002, the State Government do hereby constitute the Juvenile Justice Boards in the Districts for exercising the powers and discharging the duties conferred or imposed on such Boards in relation to Juveniles in conflict with law under the abovementioned Act and Rule.

2. The Juvenile Justice Boards are constituted in the Districts named in the following manner:—

3. The Board shall meet at such times and shall observe such Rules and procedure in regard to the transaction of business at its meetings as prescribed under the J. J. Rules.
4. The appointment of any member of the Board may be terminated after holding in inquiry, by the State Government, if,
- (i) He/She has been found guilty of misuse of power vested under this Act
 - (ii) He has been convicted of an offence involving moral turpitude and such conviction has not been reversed or he has been granted full pardon in respect of such offence.
 - (iii) He fails to attend the proceedings of the Board for consecutive three months without any valid reason or he fails to attend less than three-fourth of the sitting if a year.
5. The Board shall have a tenure of three years and the appointment of the Members shall be coterminous with the tenure of the Board.
