NOTIFICATION

The 9th April 2007

S.R.O. No. 193/2007—Whereas the draft of certain rule further to amend the Orissa Motor Vehicles Rules, 1993 was published as required under sub-section (1) of Section 212 of the Motor Vehicles Act, 1988 (59 of 1988) in the extra-ordinary issue No.1800 of the *Orissa Gazette*, dated the 25th December, 2006 under the Notification of the Government of Orissa in the Commerce and Transport (Transport) Department Notification No.10768-LC-I-A-10/2006, dated the 18th December 2006 inviting objections and suggestions from all persons likely to be affected thereby till the expiry of a period of 30 days from the date of publication of the said Notification in the *Orissa Gazette*.

And whereas no objections and suggestions has been received in respect of the said draft.

Now, therefore, in exercise of the powers conferred by Section 96 of the said Act, the State Government do hereby make the following rules further to amend the Orissa Motor Vehicle Rules, 1993.

1. (1) These rules may be called the Orissa Motor Vehicles (Amendment) Rules, 2007.
(2) They shall come into force on the date of their publication in the *Orissa Gazette*.

2. In the Orissa Motor Vehicle Rules, 1993 (hereinafter referred to as the said rules), in rule 2, in sub-rule (1),

(i) after clause(c) following clause shall be inserted, namely:—

“(c-i)” Deluxe Service Carriage “means the Stage Carriages other than Deluxe category operating with single stoppage and stoppages in an average distance of fifty kilometers covered by its routes”;

NOTE - Deluxe Stage Carriage shall be constructed and designed as per the specification as may be notified by the Government from time to time in the official Gazette and the seats of which shall be laid out with the specification made in the Seventh Schedule.

(ii) in clause (d), for the words “fifteen” the word “twenty-five” shall be substituted;

(iii) after clause (f), the following clause shall be inserted, namely:—

“(f-i) Ordinary Service Carriage ”means a Stage Carriage with a permit authorizing the same to stop, to pick up and set down passengers once in an average distance of five kilometers covered by its route with the exception of District, Sub-division, Tahasil, Block Headquarters en-route and the place of its starting and terminus;”and

(iv) after clause (m), the following clauses shall be inserted, namely:—

“(m-i) Super Express Stage Carriage ”mans a Stage Carriage with a permit authorizing the same to stop, pick up and set down passengers once in an average distance of fifty kilometers covered by its route, with the exception of District and Sub-divisional Headquarters en-route;”

“(m-ii) Super Fast Express Stage Carriage ”means a Stage Carriage with a permit authorizing the same to stop, pick up and set down passengers having single stoppage in between two terminus with the exception of District Headquarters en-route;”

3. In the said rules, in rule (3), after clause (ii) the following clause shall be inserted, namely:—

“(iii) In case of international Driving Permit—

- (a) Transport Commissioner-*cum*-Chairman, State Transport Authority, Orissa.
- (b) Additional Commissioner, Transport(Technical),
- (c) Principal, Driving Training School, Bhubaneswar,
- (d) Deputy Commissioner, Transport of the respective Zones.”

4. In the said rules, before the words “Joint Commissioner, Transport (Technical)” wherever appear, the word and oblique “Additional/” shall be inserted.

5. In the said rules, in rule 18,—

- (a) in sub-rules (1), before the words “Deputy Commissioner, Transport”, the words and obliques “Additional/Joint Commissioner, Transport(Technical)/” shall be inserted; and

(b) in sub-rule (3), in clause (ii), before the words “Deputy Commissioner Transport”, the words and oblique “Additional/Joint Commissioner, Transport (Technical)/”shall be inserted.

6. In the said rules, in rule 83, sub-rule (1) shall be deleted.
