#### **NOTIFICATION**

No.6235-ENV.I.-40/2007/F&E.— Whereas the State Government have fixed the fee for consent for establishment and consent for operation of different industrial plants in the notification of the Government of Orissa in the Forest and Environment Department No.26983/F&E., dated the 29th December,1998 and Notification No.26980/F&E., dated the 29th December, 1998 as amended by the Notification No.11755/F&E., dated the 5th August, 2004, respectively, under the Water (Prevention and Control of Pollution) Act, 1974 (6 of 1974) and Orissa Water (Prevention and Control of Pollution) Rules, 1983;

And whereas the State Government have considered it expedient to revise the fee for application for consent for establishment and consent for operation of different industries and other activities in Orissa identifying the industries into Red, Orange, Green and non-polluting categories in the Forest and Environment Department Order No. 6194/ F & E., Dated the 24th April, 2007;

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 25 of the said Act read with Rule 22 of the said Rules and in super-session of the said notifications No.26983/F&E. and No.26980/F&E., dated the 29th December, 1998 and No.11755/F&E., dated 5th August, 2004, the State Government do hereby fix the fees in the Schedule below for application for consent for establishment and application for consent for operation of different category of industries and other activities mentioned against each in that Schedule with immediate effect.

Concession of 25% in consent fees will be allowed for the following categories of industries/operation.

- (i) Industries manufacturing / proposed to manufacture products with ecomark.
- (ii) Any industry utilizing at least 70% of waste product generated from other industries as its major raw material such as fly ash brick unit, cement plants using fly ash and/or slags etc. Units having waste utilization as captive consumption shall not get this benefit.
- (iii) Units engaged in waste treatment/processing/disposal such as sewage treatment plant for ULBs, municipal solid waste management or processing plants, CETPs etc.
