RESOLUTION

The 26th May 2008

SUBJECT — Promotion of Lady Village Level Workers to the post of S.E.O./L.S.E.O.

After the formation of separate Department of Women & Child Development Department with effect from the 25th November 1994, S.E.Os./L.S.E.Os. have been declared as district cadre posts by an office order issued in W. & C.D. Department Office Order No. 22784-W.C.D., dated the 30th December 1999.

Considering the necessity of filling up the post of S.E.O./L.S.E.O., it is now decided by the Government that the vacancies of S.E.Os./L.S.E.Os. in each district be filled up by way of promotion from the cadre of L.V.L.Ws. up to an extent of 30% and through direct recruitment up to an extent of 70% as per the details below :

After careful consideration of the matter, it is hereby ordered that —

1. 70% of the posts shall be filled through direct recruitment, the detailed procedure for which is being issued separately.
2. 30% of the posts will be filled up by graduate L.V.L.Ws. with minimum five years of experience by promotion.

Provided in a district where L.V.L.Ws. having requisite qualification and experience are not available, such number of posts shall be filled up through direct recruitment.

3. The Department Promotion Committee for promotion/selection to the post of S.E.O./L.S.E.O. shall consists of the following members —

(a) Collector of the district	..	Chairman
(b) District Welfare Officer	..	Member
(c) C.D.M.O.	..	Member
(d) D.S.W.O.	..	Member

The Committee shall consider for promotion of L.V.L.Ws. to the rank of S.E.O./L.S.E.O. on the basis of seniority and suitability.

While considering for promotion the rules of ORV Acts, 1975 of S.T. and S.C. Development Department/guidelines of G. A. Department for promotion of employee and other relevant rules of Government will be strictly followed.

The Collector on record may authorize the senior most A.D.M. to be the Chairman in his absence.

In that event, the panel shall ultimately be approved by the Collector

4. Every person appointed to the post of S.E.O./L.S.E.O. shall be on probation for a period of two years from the date of actually joining the post.

ORDER—Ordered that this Resolution be published in the extraordinary issue of *Orissa Gazette* and copies thereof be forwarded to all Departments/all heads of Departments/all Collectors/all District Social Welfare Officer/Principal, A-G., Orissa.
