RESOLUTION

The 11th June 2008

**SUBJECT**—Providing bicycle to S.C. / S.T. Girl students studying in Class VIII to XII in scheduled areas and Class XI and XII in non-scheduled areas.

With a view to encourage and promote education for girl students belonging to S.C. / S.T. category in the State of Orissa, the Government in Women & Child Development have been pleased to implement a scheme of providing bicycles to S.C. / S.T. girl students studying in Class VIII to XII in scheduled areas and Class XI & XII in non-scheduled areas in Government and Government aided schools.

2. The Collector of the concerned district will identify the eligible S.C. / S.T. girl students accordingly.

3. Transparency shall be maintained for the purchase and distribution of bicycles under the scheme by proper identification supported by documentary evidence. A logo indicating the word 'Government of Orissa' and "Not for Sale" should be superscribed on the body of the bicycle.

4. The State Government in W.& C.D. Department have been pleased to constitute a District Level Committee with the following members :—

The District Level Committee will also take steps to identify all eligible cases, place order with suppliers and ensure delivery of bicycles to all eligible S.C. and S.T. girls as per the scheme guideline. The Collectors are authorized to purchase the bicycles by calling for tenders within their districts and supply the bicycles to eligible S.C. & S.T. girls of their districts within two months.

5. The cost of the bicycle will not exceed Rs.2,000 (Rupees two thousand).

6. Under the scheme, bicycle will be provided to all S.C./S.T. girls as mentioned above except those who have been provided bicycles by the Government or by any other organization/institution/agency earlier. Any other clarification required in this regard may be obtained for Women & Child Development Department.

7. The Collector concerned will calculate the requirement of funds for implementation of the scheme in his/her district and submit the requirement of funds to W.&C.D. Department within a fortnight.

8. This has been concurred in by Finance Department vide their U.O.R. No.259—SS-II., dated the 5th June 2008
