ORDER

The 7th June 2008

No. 2561/SEC.— WHEREAS, the State Election Commission had directed not to publish the final Electoral Roll in respect of Berhampur Municipality vide Commission's letter No. 1648, dated the 22nd April 2008 in view of the clarification sought for by the District Magistrate, Ganjam in pursuance of the interim order dated the 10th March 2008 of the Hon'ble High Court in W.P (C) No.3433/2008 (Anil Kumar Nayak Vrs. State and Others) ;

WHEREAS, the Hon'ble High Court vide its order dated the 15th May 2008 have dismissed the aforesaid writ petition and the District Magistrate, Ganjam has duly intimated the fact vide his letter No. 1384, dated the 7th June 2008;

NOW, THEREFORE, in exercise of powers conferred under Article 243ZA of the Constitution of India read with Section 13 of the Orissa Municipal Act, 1950, the State Election Commission hereby directs that final publication of the Electoral Roll in respect of Berhampur Municipality shall be done as per the following schedule.
