ORDER

No. 2660—Ele. (ML)-16/2008-SEC.—Whereas, it is reported by the Executive Officer, Kantabanji N.A.C. that casual vacancy in the Office of Chairperson of Kantabanji N.A.C. has occurred due to disqualification of Chairperson declared by the learned Court of Hon'ble District Judge-*cum*-Election Tribunal in election petition 96 of 2003 and 97 of 2003 ;

Whereas, it is necessary to conduct by-election to fill up the said casual vacancy ;

Now, therefore, in exercise of powers conferred under Section 49 of The Orissa Municipal Act, 1950 and Rule 68 of The Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, the State Election Commission appoints the following dates for holding of election to fill up the aforesaid casual vacancy.
