ORDER

The 19th June 2008

No. 2700—Legal-35/2008-SEC.—Whereas, the State Election Commission had directed not to publish the final Electoral Roll in respect of Nilagiri N.A.C. vide Commission's Letter No.1179, dated the 2nd April 2008 in view of the clarification sought for by the Additional District Magistrate, Balasore in pursuance of the interim order, dated the 10th March 2008 of the Hon'ble High Court in W.P. (C) No. 3316/2008 (Kshitish Chandra Ray Vrs. State & Others);

Whereas, the Hon'ble High Court vide their order, dated the 1st May 2008 have disposed of the case with a direction to the petitioner to appear before the Appellate Authority on the 12th May 2008 and the Appellate Authority on production of certified copy of this order shall fix a date of hearing of the matter and conclude the same by the 15th June 2008 ;

Whereas, the Appellate Authority i.e. the Government in Housing & Urban Development Department have complied under the orders of the Hon'ble High Court and duly intimated the Commission vide its Memo No. 16671, dated the 18th June 2008 ;

Now, therefore, in exercise of powers conferred under Article 243-ZA of the Constitution of India, read with Section 13 of the Orissa Municipal Act, 1950, the State Election Commission hereby directs that final publication of the Electoral Roll in respect of Nilagiri N.A.C. shall be done as per the following Schedule :—
