ORDER

No. 47—Ele.-(ML)-55/2008-SEC.—Whereas, it is reported by the Executive Officer, Sundargarh Municipality that casual vacancy in the office of Chairperson of Sundargarh Municipality has occurred due to no-confidence motion passed against the Chairperson on the 27th December 2007 ;

Whereas it is necessary to conduct by-election to fill up the said casual vacancy ;
