RESOLUTION

The 12th August 2008

SUBJECT— Procedure to be followed for filing complaint before the Police Complaints Authority.

In order to streamline uniform procedure to be followed for filing complaints before the Police Complaints Authority conferred in the Lokpal, Orissa vide Home Department Notification No. 22123, dated the 1st May 2008, it has been decided by the State Government to prescribe the following procedure to be followed with immediate effect until further orders.

1. Every complaint made against any Police Officers irrespective of the rank shall be made in Form - A accompanied by an affidavit in Form -B and other documents if any, on which the complainant relies (Form - A and Form - B are prescribed in the Appendix).
2. Complaint against a Police Officer is to be made before expiry of 12 (twelve) months from the date on which the action/event complained against had occurred or came to the knowledge to the comptainant.
3. Every complaint shall be accompanied by a fee payable in shape of court fee stamp of the following value:
 - (a) in case of a complaint involving a Police Officer of the rank of Additional Superintendent of Police and above of Rs. 50.00 ,and
 - (b) in case of complaint involving any other Police Officer Rs. 25.00. Provided that no court fee shall be payable in case of complaint made by a woman, a physically challenged person, a member of the S. Cs. & S. Ts., a person below the poverty line or a person in Police or judicial custody.

ORDER—The Resolution along with the Appendix be published in the Extraordinary issue of the *Orissa Gazette*. Ordered also that copies of the Resolution along with the Appendix be forwarded

to all Departments of Government/all Heads of Departments for information and necessary action. This may please be communicated to all concerned under their administrative control.
