No. 22981—DC & MA-IF-5/2008-H.—In order to implement the provisions of “Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003” read with “Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Rules, 2004” (as amended) and “Prohibition of Smoking in Public Places Rules, 2008”, State Government do hereby constitute a State Level Monitoring Committee with the following members :—

The Committee may co-opt any other person(s) as member(s)

The functions of the State Level Monitoring Committee will be :

- (1) To see whether District/local Committees have been formed
- (2) To see whether they are meeting regularly

- (3) To see whether the Authorized Officers are effectively performing their duties
- (4) To see how many cases are handled by them and what decisions are arrived at
- (5) To give suggestion/guidance to District/Local Level Committee
- (6) To take decisions on the matters referred to it by District/Local Level Committee
- (7) To collate data/information from District/Local Level Committee and forward it Ministry of Health & Family Welfare, Government of India from time to time or as may be prescribed by Ministry of Health & Family Welfare.
- (8) To recommend and initiate action in specific cases of violations of Section 5 of the Indian Tobacco Control Act, brought to the notice of the Committee.
- (9) To oversee implementation of the provision of the said Act/Rules

The members nominated to the Committee shall have term of two years and they shall not be eligible for re-nomination. Any vacancy can be filled by nomination a new member for a fresh term.
