ORDER

The 17th November 2008

No. 7094—Ele.(GP)-63/2008-SEC.—Whereas by-election programme to fill up the vacant post of Sarpanch of Padhuan Gram Panchayat under Basudevpur Panchayat Samiti in the district of Bhadrak was communicated vide Commission's Order No. 2980, dated the 11th July 2008.

Whereas, in pursuance of Orders dated the 23rd July 2008 of the Hon'ble High Court of Orissa in W.P. (C) No. 9778/2008 and report of the Collector, Bhadrak vide letter No. 1382, dated the 30th July 2008 the process of by-election for the above office was postponed by the State Election Commission vide Order No. 3460, dated the 31st July 2008.

Whereas, the Collector, Bhadrak vide his letter No. 1839, dated the 3rd November 2008 has reported that the Hon'ble Additional District Judge, Bhadrak in his Order dated the 30th September 2008 has finally disposed of the Election Misc. Appeal No. 18/2008 and requested to issue instruction to complete the process of by-election.

Now, therefore, the State Election Commission in exercise of powers conferred under Article 243-K of Constitution of India read with Section 16 of O.G.P. Act, 1994 and Rule 85 (1) of O.G.P.E. Rules, 1965 hereby appoints the following dates and time for completion of the process of by-election to the office of Sarpanch, Padhuan Gram Panchayat under Basudevpur Panchayat Samiti in the district of Bhadrak.
