DECLARATION

S.R.O. No. 567/08—WHEREAS, it was alleged that Shri Niranjan Mallick, S/o Late Bairagi Charan Mallick, At. Apania, P.S. Chauliaganj, Dist. Cuttack, State Orissa, while holding high public office in the State of Orissa, i.e. Ex-Executive Engineer, Badanala Irrigation Division, Padmapur, Dist. Rayagada committed an offence under clause (e) of sub-section (1) of Section 13 of the Prevention of Corruption Act, 1988 and that the matter was investigated in Cuttack Vigilance P.S. Case No. 14, dated the 20th March 1996;

AND WHEREAS, on scrutiny of relevant materials available on record, the State Government is of the opinion that there is *prima facie* case of commission of the offence of Shri Niranjan Mallick, who has accumulated properties disproportionate to his known sources of income by resorting to corrupt means;

AND WHEREAS, it is felt necessary and expedient by the Government that the said offender should be tried by the Special Court established under sub-section (1) of Section 3 of Special Courts Act, 2006.

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 5 of Special Courts Act, 2006 (Orissa Act 9 of 2007), the State Government do hereby declare that the said offence shall be dealt with under the Special Courts Act, 2006.
