The Government after careful consideration have been pleased to constitute a State Level Empowered Committee (SLEC) with the following members to give overall direction for smooth implementation of Orissa State Roads Project with World Bank Assistance.

The Committee has the following powers and functions :—

- (i) Power and authority to review the pace and progress of work of all road, projects included under Orissa State Roads Project.
- (ii) Review physical and financial achievement and set milestone within the framework of agreed minutes of negotiation.
- (iii) Review pre and post -implementation activity and remove the bottle -necks through inter- Departmental Co-ordination.
- (iv) At present, tenders worth Rs. 7 crores and more are finalised by the Tender Committee constituted in Works Department with Secretary, Finance, Secretary, Law Department, E.I.C.-*cum*-Secretary, Works Department and F. A., Works Department

and submit the same to Government for approval but the tenders for the project with Rs. 50 crore and above relating to Orissa State Roads Project shall be decided by Committee and obtain approval of the Government as per the World Bank norms/ guidelines for procurement of services.

- (v) Review activity of all consultants engaged for various purposes under the project and recommend measures in the event of any consultant found lagging behind in achieving the milestones incorporated in the Terms of Reference (ToR).
- (vi) It can decide engagement or disengagement of any Consultant for the project roads.
- (vii) It can review implementation of all key- action points set out in the agreed minutes of the negotiation except the portion that may fall within the jurisdiction of I.S.A.P. Steering Committee.
- (viii) The Committee may give such other suitable direction or guidance within the overall framework in the best interest of the Project.

The tenure of the Empowered Committee shall be Coterminous with the Project period of Orissa State Roads Project.

ORDER—Ordered that the Resolution be published in the *Orissa Gazette* and copies thereof be forwarded to all Departments of Government/all Heads of Departments.
