ORDER

The 1st May 2008

No. 1806-SEC.—Whereas the State Election Commission vide Order No. 737, dated the 29th February 2008 had issued programme for preparation of Wardwise Electoral Roll of 94 Municipalities/N.A.Cs.

And whereas, the State Election Commission during his review on the progress of preparation of Electoral Roll found that hearing and disposal of claims and objections have not been done properly as per the rule by the Election Officers of following N.A.Cs. of Subarnapur and Kandhamal districts :
