ORDER

The 23rd July 2009

S.R.O. No. 264/2009—Whereas the Executive Officer of Joda Municipality vide his Letter No. 1377, dated the 18th July 2009 has reported that a casual vacancy in the office of Councillor of Ward No. 12 of Joda Municipality has occurred due to resignation of the Councillor.

2. The Code of Conduct is applicable to the concerned Ward of Joda Municipality from the date of notification issued by the Commission and shall remain in force till completion of counting, i.e. from the 23rd July 2009 to the 29th August 2009.

3. The Political Parties are requested to deliver Form No. IX latest by 5 P. M. of the 12th August 2009 and Form No. X latest by 5 P. M. of the 13th August 2009 to the concerned Election Officer. Office of the Election Officer will remain open on the 13th August 2009 to receive Form No. X even though it is a public holiday.
