### NOTIFICATION

The 3rd August 2009

**S. R. O. No. 302/2009**—In exercise of the powers conferred under Section 33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972) the State Government do hereby declare that the land situated in village Chandrasekharpur and Palsakutuni under Boudh Tahasil of the district of Boudh mutated and transferred for compensatory afforestation purpose against the diversion of forest land for construction of Canal system in Bagh Barrage Irrigation Project (Phase II) of Boudh Irrigation Division, Boudh vide Government of India, Ministry of Environment & Forests orders in their letter No.8—16/2007-FC, dated the 18th December 2007 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 29.85Ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Chandrasekharpur & Palkutuni Protected Forest” :
