ORDER

SUBJECT—Rate of payment of requisition charges to Private Vehicles.

No. 3822—Ele.(G.P.)-34/2009-SEC.—In supersession of all previous orders on the subject, the State Election Commission, Orissa has been pleased to fix the rates of compensation for different types of privately owned vehicles taking into account the rate fixed by the Home (Election) Department for payment for requisition of different types of Private Vehicles for Election/By-election to Panchayati Raj Institutions/Urban Local Bodies by the District Magistrates within the State as indicated in the Schedule below :

2. When a vehicle is detained for more than 12 hours in any day this will be treated as on duty for a full day and vehicles detained for less than 12 hours will be treated as duty for a half day and compensation will be paid accordingly.

Before making the full payment, it should be certified that POL issued to the vehicles have been fully utilised for Election duty. In case of unutilised POL in a vehicle the value thereof should be deducted from the bill of the said vehicle. Separate Log Book in duplicate should be maintained for each vehicle.

This will be given effect from the 12th August 2009.
