ORDER

S. R. O. No. 320/2009—Whereas Executive Officer of Polasara N.A.C. vide his Memo. No. 1059, dated the 14th August 2009 has reported that a casual vacancy in the Office of Councillor of Ward No. 05 of Polasara N.A.C. has occurred due to resignation of the Councillor;
