NOTIFICATION

S.R.O. No. 342/2009—In exercise of the powers conferred under Section 33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the land situated in village Sana Thelakudar under Bonai Tahasil of the district of Sundargarh mutated and transferred for compensatory afforestation purpose against the approved diversion of forest land for Iron ore Mining by (a) M/s. MGM Mineral Ltd. & (b) M/s. MG Mohanty of village Patabeda vide Government of India, Ministry of Environment & Forests order in their Letter No. 8 (21)—28/2003-FCE., dated the 25th May 2004 & No. 8(21)—27/2003 -FCE., dated the 12th January 2004 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 39.723ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Sana Thelakudar (A) Protected Forest”.
