NOTIFICATION

S.R.O. No. 350/2009—In exercise of the powers conferred under Section 33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the following land situated in village Guptaganga under Telkoi Tahasil of the district of Keonjhar mutated and transferred for compensatory afforestation purpose against the approved diversion of forest land for the following projects under Section 2 of the forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 38.905ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Guptaganga Protected Forest”.
