NOTIFICATION

S.R.O. No. 351/2009—In exercise of the powers conferred under Section 33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the following land situated in Dhaladihi village under Telkoi Tahasil of the district of Keonjhar mutated and transferred for compensatory afforestation purpose against the approved diversion of forest land for Gandhamardan Block-B Iron Mines of M/s. Orissa Mining Corporation Ltd. vide order No. 8—81/2005-FC., dated the 24th April 2006 of Government of India, Ministry of Environment & Forest under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 159.9685 ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Dhaladihi Protected Forests”.
