### NOTIFICATION

The 20th August 2009

**S.R.O. No. 353/2009**—In exercise of the powers conferred under Section 33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the following land situated in Sukadola village under Telkoi Tahasil of the district of Keonjhar mutated and transferred for compensatory afforestation purpose against the approved diversion of forest land for Iron and Manganese Mines in Sidhamatha R.F. of Dr. Sarojini Pradhan vide order No. 8—100/2006-FC., dated the 21st September 2006 of Government of India, Ministry of Environment & Forest under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 85.55 ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Sukadola Protected Forests”.
