NOTIFICATION

The 22nd August 2009

S. R. O. No. 358/2009—In exercise of the powers conferred under Section 33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the land situated in village Nichemaska No. 10 under Thuamul-Rampur Tahasil of the district of Kalahandi mutated and transferred for compensatory afforestation purpose in favour of Divisional Forest Officer, Kalahandi (South) Division, Bhawanipatna against the diversion of forest land in Niyamgiri R.F. and in village forests of Kalahandi district, Orissa for construction of Conveyor Corridor and Mines Access Road to Lanjigarh Bauxite Mining Lease of M/s Orissa Mining Corporation Limited vide Government of India, Ministry of Environment and Forests orders in their letter No.8-23/2005-FC., dated the 15th April 2009 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 13.21 ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as "Nichemaska-F Protected Forest" :
