RESOLUTION

The 11th August 2009

SUBJECT—Cash rewards to members of the Armed Forces winning Gallantry and Non-Gallantry Awards.

Grant of cash rewards to members of the Armed Forces winning Gallantry and Non-Gallantry Awards and monetary grant in lieu of Agricultural land to landless Non-Commissioned Officers (NCOs) of Armed Forces had been last revised in Home Department Resolution No. 25219-Poll., dated the 30th May 2003.

2. After careful consideration of the demands made by various stakeholders for enhancement of cash rewards for the winners of Gallantry and Non-Gallantry awards, Government have been pleased to enhance the cash rewards to the members of the Armed Forces receiving these awards.

3. The rates of cash rewards to the members of Armed Forces winning Gallantry and Non-Gallantry Awards shall be as indicated in Column (3) of the Annexure I.

4. The cash rewards shall be given subject to the following terms and conditions and in the manner indicated :—

- (i) All the applications shall be submitted through Rajya Sainik Board, Orissa only. The applications shall be forwarded to Home Department by the Rajya Sainik Board with their recommendations and certificates as detailed hereinafter.
- (ii) The members of Armed Forces residing permanently in Orissa only shall be eligible to get the cash rewards. A residential certificate of Tahasildar concerned shall be submitted. The permanent residential status shall also be certified by the Secretary, Rajya Sainik Board, Orissa.

- (iii) The cash rewards shall be granted on the basis of the citation or certificate of award issued by the Ministry of Defence. A xerox copy of the citation/certificate shall be submitted along with the application. The Secretary, Rajya Sainik Board shall authenticate the xerox copy of such citation/certificate. This will be a conclusive proof of the Award in question.
- (iv) The cash reward given to the next of kin in case of Awards granted posthumously the same shall be given in lump sum.
- (v) Old cases, having been already rewarded, shall not be reopened.
- (vi) Pending cases till issue of this order will be disposed of in accordance with Home Department Resolution No. 25219, dated the 30th May 2003.
- (vii) Cases accruing after issue of this order will be governed by this Resolution.
- (viii) The cash reward shall not be given if such reward have been given to the Awardees by any other State Government. An affidavit sworn in before a Magistrate to this effect shall be submitted by Awardees along with the application.

5. No annuity or monetary grant in lieu of land or lands shall be paid or given to the winners of Gallantry and Non-Gallantry Awards.

6. The application for the cash reward shall be submitted in the format enclosed in Annexure-II.

7. A suitable officer of Home Department shall be declared as the Drawing and Disbursing Officer in respect of cash reward.

8. The charge is debitable to "Demand No. 01—2070—OAS—Non-Plan—X-00—106—Civil Defence—1358—State Organisation—41048—Grants—128—Contribution to Jawans & their Relatives" voted in the Budget Estimate for the concerned Financial Year.

9. This order will take effect from the date of its issue.

1. Cash reward is available to both Gallantry and Non-Gallantry Award Winners.
2. This Application Form duly filled in is to be submitted to Rajya Sainik Board, Orissa under a covering letter addressed to the Principal Secretary to Government, Home Department, Orissa (Through Rajya Sainik Board).
3. The Government of India Gazette Notification, Citation /Certificate and the Residential Certificate shall be produced at appropriate time in original before the Secretary, Rajya Sainik Board, Orissa for attestation of the Xerox copies enclosed with the Application Form. Release Certificate and Pension Payment Order (in case of Retired personnel) also shall be produced in original before the Secretary, Rajya Sainik Board for attestation of Xerox copy.
4. In case of serving personnel, the service certificate issued by the unit shall be enclosed in original with the application form.
5. Portions not applicable shall be scored out, wherever the choice exists. Tick mark the portion to indicate your choice.
6. Incomplete applications shall be rejected without any intimation to Applicant.
7. The Rajya Sainik Board shall not be responsible for late receipt of application due to postal or other delay and such application may be rejected.
8. In case of deceased personnel, the cash rewards shall be available to next of kin (NOK) in such case the applicant may submit this Form and Affidavit under his/her signature disclosing his/her relationship with the deceased at Serial Number-1 of the application along with copy of Death Certificate and Legal Heir Certificate.
