### NOTIFICATION

The 29th August 2009

**S. R. O. No. 370/2009**—In exercise of the powers conferred under Section 33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the land situated in village Sirimaska No. 116 under Thuamul-Rampur Tahasil of district Kalahandi mutated and transferred for compensatory afforestation purpose against the diversion of forest land for Lanjigarh Bauxite Mines Project of M/s. Orissa Mining Corporation Limited vide Government of India, Ministry of Environment & Forests order in their letter No.8-23/2005-FC., dated the 11th December 2008 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 82.52 Ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as "Sirimaska-'B' Protected Forest".
