No. 4509—Ele. (ML)-61/2009-SEC.—Whereas, it is reported by the Executive Officer, Paradeep Municipality that casual vacancy in the Office of Vice-Chairperson of Paradeep Municipality has occurred due to no-confidence motion passed against the Vice-Chairperson on the 12th August 2009;
