RESOLUTION

The 12th May 2009

SUBJECT—Inclusion of B.A. with Shastri and B.A. with Snatak in the revised common qualification of Hindi Teachers of Secondary Schools and fixation of their pay.

In School & Mass Education Department Resolution No. 3424, dated the 18th February 2008 principles of fixation of pay of Hindi Teachers in Government, Fully Aided and Block Grant High Schools possessing revised common qualification was prescribed. Subsequently certain difficulties have been pointed out by the Director, Secondary Education, Orissa, Bhubaneswar in his letter No. 35473, dated the 11th July 2008 in regard to fixation of pay prescribed in Para. 13 of the said Resolution.

In the meantime, the qualification B.A. with Shastri and B.A. with Snatak (acquired by June 2005, the date up to which temporary recognition had been granted) have been treated as equivalent to B.A. in Hindi vide S. & M. E., Department Order No. 20561, dated the 22nd October 2008.

After careful consideration, Government have been pleased to decide that the above qualification shall be included in Para. 10 of the Resolution No. 3424, dated the 18th February 2008 and the fixation of pay prescribed in Para. 13 of the said Resolution shall be modified/revised to the extent indicated below :

**1. Qualification :** The minimum educational qualification for the post of Hindi Teacher in a High School irrespective of Government, Fully Aided, Block Grant and Recognized shall be as below :

A Bachelor's Degree from a Recognized University with Hindi as one of the elective subject or with Rastrabhasa Ratna from Rastrabhasa Prachar Samiti, Wardha or with Shastri from Orissa Rastra Bhasa Parishad, Puri or with Snatak (acquired by June 2005, the date up to which temporary recognition had been granted) from Hindi Siksha Samiti, Orissa, Cuttack or an equivalent Degree

from a Recognized Institution and Hindi Shikshyan Parangat from Kendriya Hindi Sansthan, Agra/ Hindi Teachers Training Certificate Course from Hindi Training Institutes, Cuttack, Bhubaneswar and Sambalpur.

**2. Fixation of Pay :** The Hindi Teachers possessing the revised common qualification shall be entitled to the Scale of Pay at par with Trained Graduate Teacher Scale of Pay. The Pay of such Hindi Teachers shall be fixed nationally as per Rule 74 (b) of Orissa Service Code with effect from the date of possessing revised common qualification. The actual financial benefit shall be from the 1st January 2006.

The quantum of Block Grant of Hindi Teachers continuing with the revised common qualification in Block Grant High Schools shall be determined at par with T.G. Teachers of same Schools in accordance with G.I.A. Order, 2004, read with Amendment Order, 2007 with effect from the 18th February 2008, the date of issue of Resolution No. 3424, dated the 18th February 2008 of S. & M.E. Department.

The Resolution will come into force with immediate effect.

This Resolution is issued with the concurrence of Finance Department vide their UOR No. 544-CS-IF., dated the 16th December 2008.
