No. 666-70 of 1992 Vishaka and others *Vrs.* State of Rajasthan and others and in supersession of the notification of the Government of Orissa in women & Child Development Department No. 14457-W. CD., dated the 5th July 2008 and Notification No. 19069, dated the 4th November 2009, the State Government do hereby reconstitute the State Level Committee consisting of the following members, namely :—

2. The working of the Committee shall be in accordance with the Order of the Hon'ble Supreme Court in the matter of Vishaka *Vrs.* State of Rajasthan and the Code of Conduct for the Workplace formulated by National Commission for Women in keeping with the Order of the Supreme Court in the above case and the instructions issued by the State Government in this regard from time to time.

3. The Complaints Committee may meet as often as necessary but shall be required to meet at least once in every two months to receive, hear examine, enquire into and dispose of complaints of sexual harassment of women at the workplace of women employees working in various Departments in the Secretariat, Heads of Department and other attached Government Offices, State P.S.Us. and Apex Co-operative Organisations in Bhubaneswar. It will not cover establishments attached to the constitutional authorities like Raj Bhavan, Orissa, Legislative Assembly, Lokpal, Orissa Administrative Tribunal and other similar institutions.

The tenure of the committee shall be for a period of two years from the date of publication of this notification in the *Orissa Gazette*.
