No. 4654—J.J.-Cell-50/2006(Pt.)-WCD.—In pursuance of sub-sections (1) and (2) of Section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2000, read with Rule 3 of the Juvenile Justice (Care and Protection of Children) Orissa Rule, 2002, the State Government do hereby reconstitute the Juvenile Justice Board in the district of Boudh, Cuttack, Kendrapara and Kandhamal in following manner for exercising the powers and discharging the duties conferred or imposed in such Boards in relation to Juveniles in conflict with law under the above-mentioned Act and Rule.

2. The Board shall meet at such times and shall observe such rules and procedure in regard to the transaction of business at its meetings as prescribed under J.J. Rules.

3. The appointment of any Member of the Board may be terminated after holding inquiry by the State Government if—

(i) he/ she has been found guilty of misuse of power vested under this Act;

(ii) he/she has been convicted of an offence involving normal turpitude and such conviction has not been reversed or he/she has not been granted full pardon in respect of such offence;

(iii) he/ she fails to attend the proceedings of the Board for consecutive three months without any valid reason or he/she fails to attend less than threefourth of the sitting in a year.

4. The Board shall have tenure of three years and the appointment of the Members shall be coterminus with the tenure of the Board.
