**S.R.O. No. 96/2010**—The following draft of certain notification which the State Government propose to make in exercise of the powers conferred by sub-section (1) of Section 3 of the Orissa Agricultural Produce Markets Act, 1956 (Orissa Act 3 of 1957) declaring their intention of regulating the purchase and sale of the Agricultural produces as specified in the Schedule 'A' to the notification in the areas of proposed Rairangpur Regulated Market Committee in the district of Mayurbhanj so specified in the Schedule 'B' to the notification is hereby published as required by sub-section (2) of the said section of the said Act for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration by the State Government on or after the period of 30 days from the date of publication of the said notification in the *Orissa Gazette*.

Any objection or suggestion which may be received in respect of said draft by the Director, Agricultural Marketing, Orissa before the expiry of the period of 30 days as so specified shall be considered by the State Government.
